LOUISIANA, AND THE RIGHT TO ERECT, CONSTRUCT, RELOCATE, REPLACE, OPERATE AND MAINTAIN POLES, MASTS, SUPPORTS, WIRES, CABLES, TRANSMISSION MAINS, WATER TREATMENT PLANTS AND FACILITIES, WATER DISTRIBUTION LINES, PUMP STATIONS, STORAGE TANKS, FIBER OPTICS AND OTHER TECHNOLOGY ADVANCES RELATED TO UTILITY OPERATIONS, TELEMETRY AND COMMUNICATION SYSTEMS, AND ANY AND ALL OTHER APPLICANCES OR EQUIPMENT USEFUL OR NECESSARY IN CONNECTION WITH THE PRODUCTION, TREATMENT, TRANSMISSION, STORAGE, DISTRIBUTION, DELIVERY AND/OR SALE OF WATER SERVICE ON, OVER, UNDER, ALONG, UPON, AND ACROSS ALL OF THE PRESENT AND/OR FUTURE STREETS, ROADS, HIGHWAYS, ALLEYS, AND PUBLIC PLACES OF THE CITY OF BASTROP, LOUISIANA, AND THE RIGHT TO CONNECT ANY SUCH FACILITIES TO ANY OTHER FACILITIES FOR THE PURPOSE OF SELLING, TREATING, STORING, TRANSPORTING AND/OR DISTRIBUTING WATER SERVICE INTO, THROUGH OR BEYOND THE BOUNDARIES OF THE CITY.
